RESOLUTION NO. 01-2001

RESOLUTION INCLUDING THE CENTRAL MANAGEMENT INFORMATION OFFICE (CMIO) OF THE DEPARTMENT OF FINANCE TO THE NALECC SUB-COMMITTEE ON INTERPOL AND IN OTHER NALECC SUB-COMMITTEES

WHEREAS, Presidential Memorandum Circular No. 92 dated February 15, 1993 designated the Philippine National Police as INTERPOL National Central Bureau (NCB) for the Republic of the Philippines;

WHEREAS, Paragraph 7 of the above-mentioned circular provided the membership of the INTERPOL National Central Bureau (NCB) and that the Heads of other agencies as additional members shall be determined by the National Law Enforcement Coordinating Committee (NALECC);

WHEREAS, the 86TH NALECC Regular Meeting on November 17, 2000, Atty Pancho B Garong, Executive Officer, Department of Finance (DOF) CMIO-Intelligence Division informed the Body that the Economic Intelligence and Investigation Bureau (EIIB), one of the member-agencies of the NALECC, was already deactivated by virtue of Executive Order No. 191, "Deactivation of the Economic Intelligence and Investigation Bureau" dated January 7, 2000;

WHEREAS, the Executive Order was supplemented by Executive Order No. 223 "Supplementing Executive Order No. 191 on the Deactivation of the Economic Intelligence and Investigation Bureau and For Other Means by the creation of a Task Force to be chaired by the Executive Secretary, with the Secretary of Finance, the Secretary of Budget and Management and the Secretary of Justice as members, that shall provide policy guidelines for, and oversee, the final disposition of personnel, functions, assets and liabilities of the Economic Intelligence and Investigation Bureau (EIIB)";

WHEREAS, on June 29, 2000, Executive Order No. 259 was issued activating the Central Management Information Office of the Department of Finance and Integrating the Appropriate Positions of the Economic Intelligence and Investigation Bureau in said office and the Bureau of Customs and For Other Purposes.

WHEREAS, during the 87th NALECC Regular Meeting, the NALECC Body approved the membership of the Central Management Information Office of the Department of Finance to the NALECC;

WHEREAS, the Central Management Information Office of the Department of Finance requests the membership of the agency in the NALECC Sub-committee on INTERPOL;

WHEREAS, during the 88th NALECC Regular Meeting, the NALECC Body further approved the membership of the Central Management Information Office of the Department of Finance in the other NALECC Sub-Committees;

NOW THEREFORE, be it resolved as it is hereby resolved that the Central Management Information Office of the Department of Finance be included as a member of the Sub-Committee on INTERPOL and in the other NALECC Sub-Committees.
