## **RESOLUTION NO. 04-2001 A**

### **AMENDING RESOLUTION NO. 04-2001 CREATING A REVISION COMMITTEE TO REVISE CERTAIN PROVISIONS OF THE FINAL DRAFT OF THE LAW ENFORCEMENT MANUAL OF OPERATIONS (LEMO) DATED OCTOBER 26, 2001**

WHEREAS, NALECC member-agencies signified interest in having the Law Enforcement Manual of Operations submitted to the President for approval;

WHEREAS, all NALECC member-agencies were furnished a copy of the LEMO on August 27, 2001, and were given until September 15, 2001 to submit their respective comments and recommendations;

WHEREAS, the Secretariat forwarded the consolidated comments and recommendations to the Sub-Committee on Legal Affairs chaired by the office of the Chief State Prosecutor (OCSP) for evaluation on September 21, 2001;

WHEREAS, during the 94<sup>th</sup> NALECC Regular Meeting, the OCSP proposed the creation of a Revision Committee composed of representatives from the Office of the Chief State Prosecutor (OCSP); Bureau of Immigration (BI); Dangerous Drugs Board (DDB); Bureau of Trade Regulations and Consumer Protection (BTRCP); National Bureau of Investigation (NBI); Philippine Coast Guard (PCG); National Police Commission (NAPOLCOM) and PNP from which offices the proposed revisions have emanated;

WHEREAS, during the 95<sup>th</sup> NALECC Regular Meeting and Christmas Party, the Chairman, NALECC approved the Head, NALECC Secretariat's suggestion that Resolution No. 04-2001 Creating a Revision Committee to Revise Certain Provisions of the Final Draft of the Law Enforcement Manual of Operations dated October 26, 2001, be amended by specifying the OCSP as Chairman of the Revision Committee with the following as members: the National Drug Law Enforcement and Prevention Coordinating Center (NDLEPCC), the Philippine Center on Transnational Crime (PCTC), Directorate for Intelligence (DI), Directorate for Plans (DPL), Criminal Investigation and Detection Group (CIDG), Maritime Group (MARIG), and Legal Service (LS) and the request of the Department of Environment and Natural Resources (DENR), Bureau of Fisheries and Aquatic Resources (BFAR), Aviation Security Group (ASG) and the Narcotics Group (NARG) to join the revision committee.

NOW THEREFORE, be it resolved as it is hereby resolved, that a Revision Committee chaired by the OCSP and composed of representatives from BI, DDB, BTRCP, NBI, PCG, NAPOLCOM, NDLEPCC, PCTIC and the following PNP offices: DI, DPL, CIDG, ASG, NARG, MARIG, DENR, BFAR and LS be created to complete the revision of the LEMO not later than the next NALECC Regular Meeting.
