RESOLUTION NO. 14 – 2004

INCLUSION OF THE NATIONAL ANTI-SMUGGLING TASK FORCE (NASTF) AS A REGULAR MEMBER OF THE NATIONAL LAW ENFORCEMENT COORDINATING COMMITTEE (NALECC) AND ITS INCLUSION AS A MEMBER OF THE SUB-COMMITTEE ON ANTI-MONEY LAUNDERING/COUNTER FINANCING OF TERRORISM (SCAML/CFT)

WHEREAS, the National Anti-Smuggling Task Force (NASTF) was created pursuant to Executive Order No. 297 to execute programs of action for a consolidated effort to preempt, prevent and suppress smuggling, arrest smugglers and their accessories and cause their speedy prosecution;

WHEREAS, smuggling and other acts contrary to customs laws committed on a large scale or by criminal syndicates pose a serious and direct threat to the national economy by depriving the government of much needed revenue and unfairly competing with legitimate businesses and to the national security through the introduction into the country of dangerous drugs or prohibited articles;

WHEREAS, during the 114th NALECC Regular Meeting on June 11, 2004, the Body approved the motion of Director Reynaldo G Wycoco of the National Bureau of Investigation to include the National Anti-Smuggling Task Force (NASTF) as regular member of NALECC and its further inclusion to the Sub-Committee on Anti-Money Laundering/Counter Financing of Terrorism (SCAML/CFT);

WHEREAS, pursuant to Executive Order No. 41, as amended, NALECC was created to ensure a unified direction and integration of efforts by all enforcement agencies of the government involved in the enforcement of general and special laws;

NOW THEREFORE, be it resolved as it is hereby resolved that the National Anti-Smuggling Task Force (NASTF) be included as a regular member of the National Law Enforcement Coordinating Committee (NALECC).

FURTHER BE IT RESOLVED, that (NASTF) shall be a member of the Sub-Committee on Anti-Money Laundering/Counter Financing of Terrorism (SCAML/CFT).
