RESOLUTION NO. 19 – 2004

TRANSFER OF CHAIRMANSHIP OF THE NALECC SUB-COMMITTEE ON DANGEROUS DRUGS AND CONTROLLED CHEMICALS (SCDDCC) FROM THE DANGEROUS DRUGS BOARD (DDB) TO THE PHILIPPINE DRUG ENFORCEMENT AGENCY (PDEA)

WHEREAS, the Sub-Committee on Dangerous Drugs and Controlled Chemicals (SCDDCC) is one of the functional sub-committees of the National Law Enforcement Coordinating Committee (NALECC);

WHEREAS, during the 101st NALECC Regular Meeting, the Body approved request of former DDB Executive Director Usec Miguel G Coronel for the Philippine Drug Enforcement Agency (PDEA) to replace the Dangerous Drugs Board (DDB) as Chairman of the Sub-Committee on Dangerous Drugs (SCDD), for reason that Republic Act No. 9165 (The Comprehensive Dangerous Drugs Act of 2002) mandates that the Dangerous Drugs Board is the policy-making and strategy-formulating body on drug prevention and control while the PDEA serves as the implementing arm of the Board;

WHEREAS, pursuant to the Executive Order No. 41, as amended, NALECC was created to ensure a unified direction and integration of efforts by all enforcement agencies of the government involved in the enforcement of general and special laws;

WHEREAS, during the 115th NALECC Regular Meeting, Usec. Jose C Calida, Executive Director, Dangerous Drugs Board interposes no objection to the recommendation of the Chairman to pass a resolution formalizing the Chairmanship of PDEA to the Sub-Committee on Dangerous Drugs and Controlled Chemicals (SCDDCC).

NOW THEREFORE, be it resolved as it is hereby resolved that the Philippine Drug Enforcement Agency (PDEA) replaced the Dangerous Drugs Board (DDB) as the Chairman of the Sub-Committee on Dangerous Drugs and Controlled Chemicals (SCDDCC).
