WHEREAS, during the 118th NALECC Regular Meeting held at the Veterans Hall, Veterans Center, Camp Aguinaldo, Quezon City on December 9, 2004, the Body unanimously approved the inclusion of the Intellectual Property Office of the Philippines (IPOPIL) as a member of the Sub-Committee on Intellectual Coordination (SCIC).
