RESOLUTION NO. 13-2005

INCLUSION OF THE ANTI-TERRORISM TASK FORCE-NATIONAL SECURITY COUNCIL (ATTF-NSC) AS REGULAR MEMBER OF THE SUB-COMMITTEE OF FIREARMS, AMMUNITION AND EXPLOSIVES CONTROL (SCFAEC)

WHEREAS, the Sub-Committee on Firearms, Ammunition and Explosives Control (SCFAEC) is one of the functional sub-committees of the National Law Enforcement Coordinating Committee (NALECC);

WHEREAS, during the 34th Regular Meeting of Sub-Committee on Firearms, Ammunition and Explosives Control (SCFAEC) at the National Intelligence Coordinating Agency (NICA) on June 21, 2005, the members of the sub-committee unanimously approved the inclusion of ATTF as one of its regular member;

WHEREAS, the function of ATTF is to formulate strategies, policies, plans and measures necessary to prevent and suppress acts of terrorism, supervise and coordinate the implementation of government policies, coordinate with ASEAN and other nations to promote the sharing of intelligence in support of the campaign against terrorism, call open/department/agencies/bureau/task force/and other offices/bodies of government for such assistance as may be necessary in the performance of its mandate, tap government and former government officials, private individuals/corporations and other stakeholders to participate in the activities of the ATTF either as resource persons or special advisers and perform such other functions as may be directed by the President;

WHEREAS, there is a need to sustain coordination and dynamic partnership in order to effectively and efficiently suppress any act of terrorism;

WHEREAS, the ATTF needs the support of member agencies of the Sub-Committee of Firearms, Ammunition and Explosives Control because firearms and explosives are the primary tools used by terrorists to carry out their nefarious activities;

NOW THEREFORE, be it resolved, as it is hereby resolved that the Anti-terrorism Task Force-National Security Council (ATTF-NSC) be included as regular member of the Sub-Committee on Firearms, Ammunition and Explosives Control (SCFAEC);
