RESOLUTION NO. 01-2006

INCLUSION OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE), GAMES AND AMUSEMENT BOARD (GAB), METRO MANILA DEVELOPMENT AUTHORITY (MMDA), NATIONAL ANTI-POVERTY COMMISSION (NAPC), AND PHILIPPINE DRUG ENFORCEMENT AGENCY (PDEA), TO THE MEMBERSHIP OF THE SUB-COMMITTEE ON CIVIC INVOLVEMENT (SCCI)
