RESOLUTION NR. 02-2008

TERMINATION OF THE OPERATION OF THE ONE-STOP-SHOP PROCESSING CENTER

WHEREAS, the Sub-Committee on Dangerous Drugs and Controlled Chemicals (SCDDCC) is one of the functional Sub-Committee of the National Law Enforcement coordinating Committee (NALECC);

WHEREAS, the One-Stop-Shop Processing Center in Camp Crame, Quezon City is flagship project of the NALECC Sub-Committee on Dangerous Drugs and Controlled Chemicals (SCDDCC) which was established 30 July 2006, to address the problem of overlapping authorities of some national government agencies having control over certain chemicals;

WHEREAS, the One-Stop-Shop primary objective is to simplify the processing of the applications for licenses, permits and clearances issued by the government agencies with overlapping jurisdiction over some controlled chemicals, namely: the Philippine Drug Enforcement Agency (PDEA); Philippine National Police –Firearms and Explosive Division (PNP-FED); Fertilizer and Pesticide Authority (FPA); Department of Environment and Natural Resources – Environment Management Bureau (DENR-EMB); and the Bureau of Food and Drugs (BFAD);

WHEREAS, in its one year of operation, the Center was not extensively patronized for various reasons e.g. low turnout of applications for licenses and permits received at the Center, payments are still being made at the main office of the said agencies, staggered schedule of the presence of the representative of the contracting parties was not adaptable to clients, Center's functions are limited to a "message center," proximity in the distance to the main offices, lack of manpower experienced by contracting parties to regularly send representative to man the Center, and other issues;

WHEREAS, a meeting was convened on 13 August 2007, which was attended by the signatories to the Memorandum of Agreement concerned in the operation of the One-Stop-Shop, to assess the effectiveness of its one-year operation;

WHEREAS, after thorough evaluation of its performance, majority of the Contracting Parties mutually agreed that maintaining the operation of the Center is no longer practical based on the above-mentioned reasons;

WHEREAS, during the meeting of the NALECC Sub-Committee Dangerous Drugs and Controlled Chemicals held at the PNP Ante-Room, PNP Headquarters, Camp Crame, Quezon City on 15th day of August 2007 the body unanimously approved the SCDDCC Resolution No. 2007-003 recommending to the Mother NALECC the termination of the operation of the One-Stop-Shop Processing Center in Camp Crame, Quezon City.

WHEREFORE, be it **RESOLVED** as it is hereby **RESOLVED** that the One-Stop-Shop Processing Center in Camp Crame, Quezon City be terminated.

APPROVED UNANIMOUSLY this 6th day of December 2007 during the 132nd NALECC Regular Meeting and 25th Year NALECC Anniversary held at the Legenda Hotel, Waterfront Road, Subic Bay, Olongapo City.
