RESOLUTION NR. 06 - 2008

SUB-COMMITTEE ON DANGEROUS DRUGS AND CONTROLLED CHEMICALS MISSION AND FUNCTIONS

WHEREAS, the Sub-Committee on Dangerous Drugs and Controlled Chemicals (SCDDCC) is one of the functional Sub-Committees of the National Law Enforcement Coordinating Committee (NALECC);

WHEREAS, the SCDDCC is a venue of coordination for agencies responsible for the problems of dangerous drugs and controlled chemicals;

WHEREAS, the SCDDCC formulated its mission and functions to set the Sub-Committee's objective and the role of its member agencies to fortify the Sub-Committee's concerted efforts:

SCDDCC Mission

“To provide a drug-free society by engaging other government agencies the private sectors and non-government organization”

SCDDCC Functions:

- a. Foster closer coordination and cooperation among government agencies involved in the effective enforcement of the anti-drug law to ensure unified direction and integration of anti-drug efforts nationwide;
- b. Strengthen inter-agency coordination regarding anti-illegal drugs and drug related activities;
- c. Facilitate the arrest of illegal drug personalities and prosecution of illegal drug activities expeditiously;
- d. Facilitate information sharing on illegal drug personalities and activities;
- e. Provide assistance in the anti-drug campaign to other government agencies, private sectors and non-government organizations’

- f. Provide venue of discussions and monitoring of various issues and concerns affecting the anti-drug campaign of the Sub-Committee member agencies;
- g. Provide actions and recommendations on various issues of concerns affecting the anti-drug campaign of the Sub-Committee member agencies; and
- h. Submit regular reports to NALECC as may required.

WHEREAS, during the meeting of NALECC Sub-Committee on Dangerous Drugs and Controlled Chemicals at the PDEA Conference Room, Quezon City on December 11, 2007, member-agencies unanimously approved SCDDCC **Resolution No. 2007-004** recommending to the NALECC the approval of SCDDCC Mission and Functions for implementation of the Sub-Committee members in the conduct of the anti-drug campaign.

WHEREAS, during the 7th NALECC Executive Meeting the Sub-Committee on Dangerous Drugs and Controlled Chemicals presented said resolution to the body.

NOW THEREFORE, be it resolved as it is hereby resolved that the SCDDCC Mission and Functions be approved and that the SCDDCC Mission and Functions be implemented;
