RESOLUTION NR. 04-2010

INCLUSION OF THE DEPARTMENT OF HEALTH (DOH) AND THE COMMISSION ON FILIPINOS OVERSEAS (CFO) AS MEMBERS OF THE NALECC SUB- COMMITTEE ON ILLEGAL RECRUITMENT (SCIR)

WHEREAS, the National Law Enforcement Coordinating Committee (NALECC) was created by virtue of Executive Order Nr. 829 as amended by Executive Orders Nr. 41 and 41-A;

WHEREAS, the Sub-Committee on Illegal Recruitment (SCIR) is one of the functional Sub-Committee of the National Law Enforcement Coordinating Committee (NALECC);

WHEREAS, the Sub-Committee on Illegal Recruitment (SCIR) consists of the following agencies as members:

WHEREAS, the DOH is responsible in giving accreditation to medical clinics where Overseas Filipino Workers (OFWs) are referred for medical consultation and may require the accredited medical clinics to submit a database of applicants for overseas employment while the Commission on Filipinos Overseas (CFO) is designated as the lead agency on the Task Force against Human Trafficking;

WHEREAS, on October 8, 2007 and 27, 2009, the Commission on Filipinos Overseas (CFO) and the Department of Health (DOH) respectively, submitted their Letters of Intent to join the Sub-Committee on Illegal Recruitment (SCIR) of the National Law Enforcement Coordinating Committee (NALECC);

WHEREAS, on March 25, 2010, members of the NALECC Sub-Committee on Illegal Recruitment (SCIR) unanimously approved Resolutions Nr. 01-2010 and 02-2010, recommending the inclusion of the Department of Health (DOH) and the Commission on Filipinos Overseas (CFO) as members of the said Sub-Committee;
